

PUBLIC PARTICIPATION IN COUNCIL MEETINGS AND PUBLIC HEARINGS IN CONFORMANCE WITH PHYSICAL DISTANCING REQUIREMENTS

In order to minimize the spread of the COVID-19 virus, the Village of Pemberton is providing an alternative to viewing Council and Committee of the Whole meetings and allow for public participation, as per the Village's [Open Question Period Policy](#) which is held during a Regular Meeting only. This alternative allows the Village to adhere to physical distancing requirements, follows the Minister of Public Safety's Ministerial Order M084 (which suspends certain requirements of the *Community Charter*), and provides a way for the public to ask questions during the Open Question Period at the end of a Regular Council meeting.

As always, meeting agendas and minutes are also available on the Village's website. Please note only Council meetings held after March 31, 2020 are available to view.

VIRTUAL PARTICIPATION BY ZOOM VIDEO CONFERENCING

In the interim, the Village of Pemberton will be offering the ability to attend live Council and Committee of the Whole meetings via "Zoom" video conferencing. Instructions for attending a meeting via Zoom are provided below.

How do I join a meeting via Zoom Video Conferencing?

Download the [Zoom software](#) on your personal computer, or download the mobile app to your smart phone or tablet. Once you have downloaded the Zoom software you will be ready for the meeting and Public Hearing on May 26, 2020, at 9:00 a.m.

Pre-registration is not required, however, you may be required to provide your name and email address when attending the webinar.

How can I provide Public Comment on Zoom?

At the Public Hearing: an opportunity for Public input will be provided at the end of the Public Hearing.

At the Regular Council Meeting: An Open Question Period is available at the end of each Regular Council Meeting. Please note that Committee of the Whole Meetings and Special Council Meetings do not allow for an open question period.

Once Mayor Richman has announced that the Public Hearing or Meeting is open for public input, please do the following:

- Click on the “Raise Hand” feature in the webinar controls. This will notify Village Staff that you have raised your hand.
- Village Staff will unmute your microphone when it is your turn to ask your question.
- A prompt will appear to confirm you would like to be unmuted. Once you accept the prompt, you will have the opportunity to ask your question.
- Once your question has ended, you will be muted again.

Please be reminded that as per the Village of Pemberton Open Question Period Policy:

- Only questions directly related to business discussed during the Council Meeting are allowed;
- Questions must be truly questions and not statements of opinions or policy by the questioner
- Not more than two (2) separate subjects per questioner will be allowed
- Attending Press will be allowed preference prior to proceeding to the public

During Question Period, I don’t want to ask my question at the meeting; can I provide my question to the Village for response another way?
