How do I join a meeting via Zoom Video Conferencing?

Please visit: <https://zoom.us/> and either sign-up for a free Zoom account or continue as a guest.

Download the [Zoom software](#) on your personal computer or download the mobile app to your smart phone or tablet. Once you have downloaded the Zoom software you will be ready for the meeting.

Pre-registration is not required. However, you may be required to provide your name and email address when attending the webinar.

How can I provide Public Comment on Zoom?

An Open Question Period is available at the end of each Regular Council Meeting. Committee of the Whole Meetings, Special Council Meetings, and Board Meetings do not include an open question period. Opportunities for public input are also available when development variance permits are presented.

Once Mayor Richman has invited comments from the public regarding a development variance permit, or announced Open Question Period, please do the following:

- Click on the “Raise Hand” feature in the webinar controls. This will notify Village Staff that you have raised your hand.
- Village Staff will unmute your microphone when it is your turn to ask your question.
- A prompt will appear to confirm you would like to be unmuted. Once you accept the prompt, you will have the opportunity to ask your question.
- Once your question has ended, you will be muted again.

Please be reminded that as per the Village of Pemberton Open Question Period Policy:

- Only questions directly related to business discussed during the Council Meeting are allowed.
- Questions must be truly questions, and not statements of opinions or policy by the questioner.
- Not more than two (2) separate subjects per questioner will be allowed.
- Attending Press will be given preference prior to proceeding to the public.
