- I am a Canadian citizen (*Landed Immigrants and Permanent Residents are not permitted to vote*);
- I have resided in British Columbia for at least six months immediately preceding voting day (April 15, 2022);
- I have resided in OR have been the registered owner of real property in Pemberton for at least 30 days immediately preceding voting day (September 15, 2022);
- I am not disqualified under the *Local Government Act* or any other enactment from voting in this election;
- I am entitled to vote and have not previously voted in this election.
