

# VILLAGE OF PEMBERTON

## BYLAW No. 730, 2013

---

A bylaw to amend the Village of Pemberton Tax Rate Bylaw No. 728, 2013 for the levying of annual tax rates for Municipal, Regional Hospital District and Regional District purposes for the year 2013.

---

**WHEREAS** it is deemed necessary to amend the 2013 Municipal tax rates.

**NOW THEREFORE**, the Council of the Village of Pemberton, in open meeting assembled, enacts as follows:

1. The following rates are hereby imposed and levied for the year 2013:
  - (a) For all lawful general purposes of the municipality on the assessed value of land and improvements taxable for general municipal purposes, rates appearing in column "A" of Schedule "A" attached hereto and forming a part hereof.
  - (b) For purposes of the Squamish-Lillooet Regional Hospital District on the assessed value of land and improvements taxable for hospital purposes, rates appearing in column "B" of Schedule "A" attached hereto and forming a part hereof.
  - (c) For purposes of the Sea to Sky Regional Hospital District on the assessed value of land and improvements taxable for hospital purposes, rates appearing in column "C" of Schedule "A" attached hereto and forming a part hereof.
  - (d) For purposes of the Squamish-Lillooet Regional District on the assessed value of land and improvements taxable for general municipal purposes, rates appearing in column "D" of Schedule "A" attached hereto and forming a part hereof.
2. The minimum amount of taxation upon a parcel of real property shall be One Dollar (\$1.00).
3. This bylaw may be cited as the "Village of Pemberton Annual Tax Rates Amendment Bylaw No. 730, 2013."
