NOW THEREFORE the Council of the Village of Pemberton, in open meeting assembled, enacts as follows:

- 1. Schedule "A" of Amendment Bylaw No. 607, 2008 is hereby deleted and replaced with a new Schedule "A" which is attached hereto and forms part of this bylaw, and which takes effect on January 1, 2009.
- a) All annual Rates, Rents and Charges provided herein commencing January 1, 2009, shall be due and payable on July 2nd, 2009. Such rates, rents and charges shall be subject to a discount of five percent (5%) if paid in full within thirty (30) days of the invoice date on which the annual fees are levied.
 - b) A 10% penalty will be added to such rates, rents and charges remaining unpaid July 2nd, 2009.
- 3. This bylaw may be cited for all purposes as the "Village of Pemberton Sanitary Sewer System Regulation Connection and Rates Amendment Bylaw No. 628, 2009."
