

THE CORPORATION OF THE VILLAGE OF PEMBERTON

BYLAW NO. 607, 2008

Being a bylaw to amend the Corporation of the Village of Pemberton Sewer Rates Bylaw No 593, 2007.

WHEREAS it is deemed necessary to amend the rates and charges and billing system for the use of the Sanitary Sewer System to meet increased operational costs of the system;

NOW THEREFORE the Council of The Corporation of the Village of Pemberton, in open meeting assembled, enacts as follows:

1. Schedule "A" of Amendment Bylaw No. 593, 2007 is hereby deleted and replaced with a new Schedule "A" which is attached hereto and forms part of this bylaw, and which takes effect on January 1, 2008.
2. a) All annual Rates, Rents and Charges provided herein commencing January 1, 2008, shall be due and payable on July 2nd, 2008. Such rates, rents and charges shall be subject to a discount of ten percent (10%) if paid in full within thirty (30) days of the invoice date on which the annual fees are levied or a discount of five percent (5%) if paid in full within thirty-one (31) days to sixty (60) days of the invoice date.
b) A 10% penalty will be added to such rates, rents and charges remaining unpaid July 2nd, 2008.
3. This bylaw may be cited for all purposes as the "Village of Pemberton Sanitary Sewer System Regulation Connection and Rates Amendment Bylaw No. 607, 2008".
