Subject: UBCM Minister Meeting Briefing Topics

PURPOSE

The purpose of this report is to seek direction from Committee of the Whole with regard to the topics to bring forward at the UBCM Convention Minister Meetings.

BACKGROUND

The annual Convention of the Union of British Columbia Municipalities (UBCM) takes place September 23rd to 27th, 2019. The Convention provides an opportunity for local governments to meet with individual Cabinet Ministers to present specific asks for the betterment of their communities.

The Village can request a meeting with any Minister at the UBCM Convention: a listing of Ministries is provided in **Appendix A**. A meeting with the Premier can also be requested. Minister Meeting requests must be accompanied by a Briefing Note which describes the topic to be addressed and the associated ask(s).

The deadline for submission of these requests has not yet been announced for 2019 however historically has been in early July.

DISCUSSION AND COMMENTS

The meeting topic should be specific and easily translated into a request for the Province's support to resolve the issue, such as financial support, through policy change, advocacy to another governing body, or improvements to Provincial assets or services. An example of a Minister Meeting Briefing Note is attached as **Appendix B**.

Each Minister Meeting is only fifteen (15) minutes in duration. To maximize this opportunity, Staff suggests that the following be considered when selecting topics:

- 1) Does the topic align with Council's Strategic Priorities (**Appendix C**)?
- 2) Has the topic been raised by Council at previous UBCM Conventions (**Appendix D**)?
If so, can it be updated to account for any recent action by the Province?

Prevalent topics brought forward by the Village in the past four years include:

- Impact of adventure tourism in the Corridor
- Road safety for cyclists and pedestrians
- Infrastructure improvements to Pemberton Creek Bridge
- Funding for emergency management/risk mitigation
- Economic vitality of residents

- 3) Is the Village currently working with Provincial or other stakeholders to address the issue?
- 4) Is the issue one of regional or corridor significance and would it be better brought forward by the Squamish-Lillooet Regional District Board?
- 5) Has Council put the topic forward as a Resolution to the LMLGA in 2019?

It should be noted that topics already submitted as Resolutions to the Lower Mainland Local Government Association (LMLGA) are not recommended as they may have already been brought forward to UBCM through the Association. In March of 2019, Council submitted the following resolutions to the LMLGA for consideration at the May Conference and AGM:

1. **WHEREAS** *the Village of Pemberton, in partnership with the regional district, other local governments, and First Nations in the Sea to Sky area are working collaboratively to develop a regional transit commission to establish a regional transit system to connect Mt. Currie to Metro Vancouver;*

AND WHEREAS *the current provincial transit commission model does not allow for representation from First Nations which does not allow for an equal representation or an equitable decision-making platform process;*

THEREFORE, BE IT RESOLVED THAT *the Province of British Columbia amend the legislation respecting the representation on commissions to include First Nations.*

2. **WHEREAS** *the negative impacts to lower mainland Provincial parks and Crown Land recreation areas continue to occur due to increasing tourism and limited funding;*

THEREFORE BE IT RESOLVED *that the Province be requested to allocate additional funding to managing B.C. Parks, specifically Joffre Lakes Provincial Park, and Crown Land recreation areas in the Sea to Sky Corridor and Lower Mainland.*

- 6) Has the topic been raised in previous UBCM Resolutions that have received Provincial response?

7) Does the topic align the Provincial government's mandate (below)?

The Provincial government has made three commitments to the British Columbians which are expressed in each Minister's Mandate Letter from Premier Horgan:

"Our government made three key commitments to British Columbians. Our first commitment is to make life more affordable. Too many families were left behind for too long by the previous government. They are counting on you to do your part to make their lives easier.

Our second commitment is to deliver the services that people count on. Together, we can ensure that children get access to the quality public education they need to succeed, that families can get timely medical attention, and that our senior citizens are able to live their final years with dignity.

Our third key commitment is to build a strong, sustainable, innovative economy that works for everyone, not just the wealthy and the well-connected. Together, we are going to tackle poverty and inequality, create good-paying jobs in every corner of the province, and ensure people from every background have the opportunity to reach their full potential".

Upon receiving direction from Committee of the Whole, Staff will research and prepare draft Briefing Notes to present to Council at a future meeting.

COMMUNICATIONS

There is no communications element required at this time.

LEGAL CONSIDERATIONS

There are no legal considerations at this time.

IMPACT ON BUDGET & STAFFING

The preparation of Briefing Notes for the UBCM Convention is incorporated into the operations of the Office of the Chief Administrative Officer and thus will not impact budget or staffing costs.

IMPACT ON THE REGION OR NEIGHBOURING JURISDICTIONS

There are no impacts on the region or neighbouring jurisdictions at this time. However, if there is an item of regional significance that Council feels is important to bring forward to a Minister meeting it is recommended that the issue be referred to the SLRD Board for consideration as part of their Minister Meeting topic review process.

There are no alternative options for consideration.

Appendix A

Listing of British Columbia Ministries

Ministry of Advanced Education, Skills & Training

The Ministry of Advanced Education, Skills & Training provides leadership and direction for post-secondary education and skills training systems in British Columbia as well as labour market information and programs.

Ministry of Agriculture

The Ministry of Agriculture is responsible for the production, marketing, processing and merchandising of agricultural products and food.

Ministry of Children & Family Development

Key Topics of Discussion: Impacts of increased tourism in the Pemberton area

Background: The Village of Pemberton appreciates the investment that the Province has made towards the promotion of tourism in the Sea to Sky area. The increase in popularity of outdoor recreation has brought positive economic impacts to our community as well as to the Province. Sadly, the increase in visitors has also brought negative impacts, such as human/wildlife conflicts, the closures of popular destinations due to unmanageable volume, and increased risk of wildfire in remote areas.

Discussion: The rapidly increasing popularity of adventure tourism has brought, ironically, threats to the natural environment that draws visitors to our area, as well as to the safety of the highway used to access it. Events such as the closure by the Province of Keyhole Falls hot springs due to increased human/wildlife conflicts and the safety challenges presented by the shocking parking overflow at Joffre Lakes in 2016 and again in 2017 serves to highlight the problem. We appreciate the Province's acknowledgement of the concerns at Joffre with the imposition of a no dog rule in the Park and look forward to further action being taken.

The additional volume without adequate resources to supervise and maintain the popular areas mentioned above, as well as camping areas down the In-SHUCK-ch highway along Lillooet Lake, including the popular Strawberry Point, pose equally great concerns such as overflowing garbage receptacles, inadequate restroom facilities and most importantly campfires that are not properly extinguished and pose a serious risk of wildfire, given the remote forest areas where sites such as this exist. Given the wildfire state of emergency that the Province experienced last summer season, the fact that climate change indicates our environment's susceptibility to wildfire is unlikely to decrease, and the astronomical cost to the Province to manage wildfires, it is crucial that additional resources be allocated to patrol, monitor and enforce Provincial regulations in the backcountry.

Though strongly supportive of economic benefits generated by adventure tourism, the Village of Pemberton Council is equally committed to the preservation of our environment. While our surrounding natural area has the capacity to draw a significant boost to the tourism industry in British Columbia, such a draw will not continue if the very environment is threatened.

As such, we request that the Province match the investment made in tourism marketing with an investment in mitigating the resulting challenges of increased visitor volume.

Request:

That the Province match the investment made in tourism marketing with the allocation of funds for improvements to infrastructure and for additional patrols of remote recreation areas to ensure the protection of the environment that supports the local and Provincial tourism industry.
